Power of Attorney

INSTRUCTION: (When power of attorney is executed in India)

- 1. Attorney (PA Holder) should be a resident of India.
- 2. Power of attorney is to be executed on a non-judicial stamp paper of as applicable to POA in respective states with one extra copy on a plain paper.
- 3. Each page of the power of attorney and wherever the blanks are filled-in should be initialed by the executants.
- 4. Signature of the executants should be ATTESTED by a Judicial Magistrate or a Notary Public

In case of non-residents, if the power of attorney is being executed outside India.

- 1. The attorney (PAHolder) should be a resident of India.
- 2. The power of attorney should be executed on a stamp paper/plain paper as the case may be as applicable in the country in which the power of attorney is executed.
- 3. The signature of the principle ie executant should be attested by any authorized official of the Indian Embassy / Indian Consulate / Trade Commissioner of India in the country where the executants resides. Alternatively the signatures of the executants can be attested by Notary Public of that country (only in cases India is having reciprocal arrangements) and adjudicated (to be stamped in India for the requisite value as applicable to respective states) in India within 2 months of receipt of POA in India.
- 4. The attorney's signature should be verified in India by Notary Public or his employer or his banker on a separate piece of paper which should be submitted to ING VYSYA BANK LTD., together with the power of attorney.
